Standardbred Declaration for transfer of trainer

This form must be used to obtain the approval of the Judge or Director for a transfer of one or more horses from a trainer of record to another trainer of record under the Rules of Standardbred Racing.

If the licence of a current trainer of record is suspended or revoked, or the trainer of record is unlicensed or otherwise ineligible to train horses in the Maritimes, the horses under his or her care and control are not eligible to be entered or to race in the Maritime Provinces until the Judges or Director have approved a transfer of the horses to one or more other trainers of record.

Note: All licensees are informed that no person whose licence is suspended under the APHRC Rules of Standardbred Racing or the enabling legislation or who is not licensed, may provide goods or services for which a licence is required with respect to race horses.

Part B Declaration, Certification and Consent - Read Carefully

1. Owner

I hereby declare and certify that I am the owner of the horse(s) identified in Part A or, in the case of a stable name, multiple ownership or estate, that I am an owner included in the stable or multiple ownership or the executor of the estate and authorized on behalf of the stable, multiple ownership or estate to make this declaration and to consent to the terms set out below.

If this application for transfer is approved by the Judges, I consent to the following terms to my licence or to licence the stable name, multiple ownership or estate:

- a) the horses identified in Part A shall be stabled and trained only on premises to which Commission officials and investigators have unimpeded access to carry out any inspection or investigation that is provided for under the Rules of Standardbred Racing or the Racing Commission Act, including any inspection or investigation that may be necessary to monitor compliance to the Judges' approval of the transfer,
- b) I will provide or cause to be provided within the time periods specified by a Commission official or investigator any information, documents or other materials related to the training or care of the horses identified in Part A that may be required by the Commission official or investigator,
- c) no horse owned by me, the stable name, multiple ownership or estate, as the case may be, trained by the proposed trainer of record once this transfer is approved shall be transferred to or trained by another trainer without the approval of the Judges,
- d) I will comply with or cause to be complied with any condition of the Judges' approval set out below,
- e) the horses identified in Part A will be ineligible for entry or racing in the Maritime if (i) a Commission official or investigator is unable to conduct any inspection or investigation where a horse is stabled or trained, (ii) any person whose licence is suspended or who is not licensed provides goods or services for which a licence is required with respect to a horse identified in Part A, (iii) the information, documents or other materials required by the Commission official or investigator within the time period specified is not provided, (iv) a horse is transferred to or trained by another trainer, or (v) the conditions of the Judges' approval are not complied with.

2. Proposed Trainer of Record

I hereby declare and certify that I am applying to be the trainer of record for the horse(s) identified in Part A and that I consent to the following terms to my licence:

- a) the horse identified in Part A shall be stabled and trained only on premises to which Commission officials and investigators have unimpeded access to carry out any inspection or investigation that is provided for under the APHRC Rules of Standardbred Racing of the enabling Legislation, including any inspection or investigation that may be necessary to monitor compliance with the Rules of Standardbred Racing, these terms and with any condition to the Judges' approval of the transfer,
- b) I will provide or cause to be provided within the time periods specified by the Director of Racing or investigation any information, documents or other materials related to the training or care of the horses identified in Part A that may be required by the Commission official or investigator,
- c) no horse owned by me, the stable name, multiple ownership or estate, as the case may be, trained by the proposed trainer of record once this transfer is approved shall be transferred to or trainer by another trainer without the approval of the Judges,
- d) I will comply with or cause to be complied with any condition of the Judges' and/or Director approval set out below,
- e) the horses identified in Part A with be ineligible for entry or racing in the Maritime if (i) a Commission official or investigator is unable to conduct any inspection or investigation where a horse is stabled or trained, (ii) any person whose licence is suspended or who is not licensed provides goods or services for which a licence is required with respect to a horse identified in section 3, (iii) the information, documents or other materials requires by the Commission official or investigator within the time period specified is not provided, (iv) a horse is transferred to or trained by another trainer, or (v) the conditions of the Judges' approval are not complied with.

Trainer Transfer Conditions

I, _____, agree to the following conditions concerning the trainer transfer of the following horse(s).

1. The APHRC investigator or designee shall be granted access to the horse(s) stabling area at any time.
2. I understand that invoices and financial information may be requested by the APHRC
3. I understand for the duration of _____ suspension that _____ is not to be associated with the day-to-day activities surrounding the horse(s) mentioned above.
4. You are to notify the APHRC if you intend to move the horse(s) to another facility
5. The APHRC must be notified if the horse(s) has been sold.

If the above conditions are violated during the previous trainer's suspension, the following penalty shall be imposed.

1. \$1,000 fine
2. Horse(s) shall be suspended for 60 days when live racing is being conducted at your home racetrack.
