Standardbred Declaration for transfer of trainer

This form must be used to obtain the apptoval of the Judge or Director for a transfer of one or more horses from a trainer of record to another trainer of record unde the Rules of Standardbred Racing.

If the licence of a current trainer of record is suspended or revoked, or the trainer of record is unlicensed or otherwise ineligible to train horses in the Maritimes, the horses under his or her care and control are not eligible to beentered or to race in the Maritime Provinces until the Judges or Director have approved a transfer of the horses to one or more other trainers of record.

Note: All licensees are informed that no person whose licence is suspended under the APHRC Rules of Standardbred Racing or the enabling legislation or who is not licensed, may provide goods or services for which a licence is required with respect to race horses.
